## SUB \_\_\_\_ 2021 RES-344 (PROPOSED-EICHER) GENERAL FUND SUPPORT FOR THE ALLIANT ENERGY CENTER

The revenues and expenses of the Alliant Energy Center (AEC) are measured differently than
other departments, with a goal of not providing general fund support, and the AEC is being
charged for services, or indirect costs. These costs are not assessed to most departments, are
provided for free.

9 Over the years, the AEC became self-sufficient through increasing business, deferring
10 maintenance, and relying on greater use of part time employees or contracted help.

At the time the AEC became temporarily self-sufficient, the County began charging the agency
for services from other county departments including the Corporation Counsel, the Department
of Administration, the Division of Information Management, and other services not charged
against the budgets of most departments, draining the already precarious AEC budget.

- Prior to the global COVID-19 pandemic, the AEC had built up a reserve fund and until recently has not required general fund support. Given the uncertainty in event revenue as a result of the pandemic, the creation of full time positions <u>may not be able to be sustained without</u> <del>would</del>
- 20 require general fund support.21

NOW THEREFORE BE IT RESOLVED that <u>the Dane County Board supports a solvent and</u>
 <u>functioning AEC that reduces the need for outside contracts in the next budget cycle, the</u>
 <u>County Board commits to which may require strategic</u> use of general fund revenues to help
 <u>reestablish a pool of limited term employees and add-fund</u> full time positions.

BE IT FURTHER RESOLVED that the County Board supports discontinuing the practice of
 requiring the Alliant Energy Center to pay indirect costs in future years. make payments for
 services to other county departments to subsidize the general fund
