Re: Bright Beginnings Day School – Application for a Conditional Use Permit

**Dear Committee Members:** 

The purpose of this letter is to make you aware that 100% of the residents of Applewood Hill are vehemently opposed to the granting of a Conditional Use Permit to Ms. Sarah Tuttle and Bright Beginnings Day School (BBDS) to operate a daycare center at 7069 Applewood Drive in our community of 41 single family homes.

It is obvious from the Conditional Use Permit application that this daycare center is strictly a business, owned by a limited liability company – LLC. Ms. Tuttle will not be living in the house. The Permit application does not meet the standards needed to award a Conditional Use Permit. In addition, the application violates the cardinal principle of our Association when it states that two (2) daycare employees will be on the premises at any time. All homes in Applewood must be occupied by one family.

Ms. Tuttle has no vested interest in our community other than her bottom line. This is not a stay—at—home mom helping families by providing daycare. Ms. Tuttle operates BBDS out of 5 homes (in Dane County) in neighborhood settings (5 homes/8 kids = 40 kids of annual childcare income). Why doesn't Ms. Tuttle open up her business in a location zoned specifically for commercial use?

We respectfully request that you deny Ms. Tuttle and Bright Beginnings Day School a Conditional Use Permit.
