The County's Emergency Mental Health Services provider (under DHS 34), Journey Mental Health Center, is the only agency allowed to authorize a stay under this contract and does so using clinical judgment of the client's presentation. Journey Mental Health Center also oversees the stay and ensures authorizations do not exceed contracted amount of days.
