1. Community Service and the Courts

Presented by Judge Genovese

Presentation regarding community service as an alternative to incarceration and/or fines. Community service acts as a pro-social alternative to incarceration, and it enables participants to get additional work experience and potentially recommendations, which can prevent recidivism. There are multiple collaborators on this program, including ATTIC, Clerk of Courts, Judiciary, and DHS. This collaboration began in 2016.

Discussion ensued. Discussion regarding opportunities for additional community service partners, and that a variety of sites allow program to tailor community service opportunities to the participants' interests. Discussion regarding partnerships with municipal court. Discussion of program expansion; a larger staff would be needed to increase the program capacity.

The Public Protection and Judiciary Fines and Fees Subcommittee conducted an analysis on fines and fees in the criminal justice system. The subcommittee examined what fines/fees exist, how these fines/fees impact people, and racial disparities in who is assessed fines/fees. The subcommittee discussed the different ways of managing fines/fees, such as increasing fee waivers, avoiding collections when possible, and creating a uniform process about fees and alternatives to collections.

1. JFA Institute Final Report Regarding the Dane County Jail Consolidation Project

Presented by Jim Austin and Allen Patrick, JFA Institute

Presentation on the JFA final report on the Dane County Jail Consolidation Project (attached, and available on cjc.countyofdane.com/reports).

Presentation of different options for the Jail Consolidation Project. Two options were presented.

Recommendation is option 2. Under this option: the Public Safety Building would not be renovated, the number of mental health beds would increase, and an infirmary would not be built (instead recommends the jail collaborate with local hospitals). This would cost a total of \$138 million, which would lead to a surplus of \$10 million that could be spent on the crisis triage center.

Discussion regarding the ten stated goals of jail consolidation project. Discussion of medical care and whether a clinic or infirmary is better suited for the new building. Discussion of the scope of the JFA analysis and whether additional research should be done on jail population forecasting. Discussion of sentencing, its impact on the jail population, and statutory limitations. Next steps include: looking into different programs, processes, and other ways to lower the jail population as well as having additional meetings of stakeholders and consultants.
