10	(b) Oversee the provision of county services and the allocation of county money to cultural
11 12	programs, encouraging maximum service and accountability in return for tax dollars;
12	(c) Plan and execute the publication of information materials such as a promotional brochure on the county as a whole; instructional packets and slide/tape presentations for
15 14	use in schools and by organizations; and assist in publishing the "Guide to Historic Dane
14	County";
16	(d) Unify and publicize the many county information services, both to prevent duplication
17	and to improve accessibility to county government while minimizing confusion; and
18	(e) Create opportunities for cultural exchange and increased interdependence of
19	communities, especially for the purpose of sharing plays, histories, and crafted materials.
20	
21	In order to plan effective meetings, a subgroup of members have been meeting as a workgroup.
22	
23	A recent update to Chapter 15 requires:
24	15.04 GENERAL PROVISIONS. (2)(a) All subcommittees in existence as of the effective date of
25	this ordinance shall be dissolved on December 31, 2017 unless continuation is approved by
26	resolution adopted by the County Board and approved by the County Executive. (b) Unless the
27	resolution authorizing a subcommittee specifies a sunset date for the subcommittee, each
28	subcommittee shall be dissolved unless reauthorized by resolution by December 31st of the year
29	following its most recent authorization.

31	In order to meet the requirements of Chapter 15, as well as the spirit of the Open Meetings Law,
32	the Commission seeks to form a formal Executive Committee of the Arts and Cultural Affairs
33	Commission.
