# Department of Housing \& Urban Development (HUD) Defined Categories of Homelessness 

## Category 1

- "Literally" homeless
- Living on the street or a place not meant as functional living space
- Living in a shelter/shelter program


## Category 2

- Imminent risk
of
homelessness
- Households who are likely to lose their current stable housing and be forced into a literally homeless episode


## Category 4

- Fleeing/Attempting to Flee Domestic Violence
- Has no alternative stable residence outside of with their abuser


# Department of Housing \& Urban Development (HUD) Defined Categories of Homelessness 

## Category 3 Homeless

- Unaccompanied youth under 25 years of age, or families with Category 3 children and youth, who do not otherwise qualify as homeless under this definition, but who:
- Are defined as homeless under the other listed federal statutes;
- Have not had a lease, ownership interest in permanent housing during the 60 days prior to the homeless assistance application;
- Have experienced persistent instability as measured by two moves or more during in the preceding 60 days; and
- Can be expected to continue in such status for an extended period of time due to special needs or barrier

$\square$ Dedicated resources/funding
Housing programs that offer financial or rental support
Comprehensive/wrap around service coordination
$\square$ Front end: housing navigation and readiness
$\square$ On-going: case management
$\square$ Longer service provision
$\square$ Landlord Engagement
$\square$ Incentive measures
$\square$ Good tenant programs

## Gaps \& Needs

Lack of resources for households experiencing homelessness by other statue
$\square$ Limitations due to HUD funding
DProgram requirements for rent-supporting income levels
$\square$ Communities that do not specifically target non-literal homelessness and/or are

- dependent on centrally located resources.
