1. Approve 2022 Cycle 2 Capital Grant Awards

Approval of 2022 Cycle 2 grant awards will be reviewed during the November 4th Executive Committee meeting for recommendation for approval by the commission during the November 9th meeting.

2. Review/Approve 2022 Cycle 2 Grant Award Distributions

- 2022 Cycle 2 grants were reviewed by Dane Arts staff for eligibility. Three sessions with three panelists each reviewed and scored the applications.

- A grant allocation formula based on final score and available funds was used to generate recommended grant allocation.

- The consensus of the commission is to fund as many applicants as possible. Since requests exceed available funds, applicants rarely receive full requests and applicants are not automatically guaranteed funding.

- Commissioner Curet recommended allocating just a \$500 minimum to Sugar River Valley Songwriters due to a score of 54% compared to the next lowest score of 75%.

- Director Fraire will alert applicants to the status of their awards and to initiate submission of required paperwork.

- Commissioner Miquelon made a motion to not fund the Sugar River Valley Songwriters CD Project, seconded by Vice Chair Klehr. The motion was carried unanimously by a voice vote.

- A motion was made by Commissioner Miquelon to approve and distribute a total of \$70,000 to 48 applicants as proposed by Commissioner Curet's allocation formula, seconded by Commissioner Puleo Moyer. The motion was carried unanimously by a voice vote.

3. Approve 2023 Commission Meeting Calendar

- The final decision will be delayed until the November Commission meeting.
