1 2022 RES-151 2 3 AUTHORIZING ADDENDUM B TO AN INTERGOVERNMENTAL AGREEMENT CONTRACT 4 WITH THE COUNTY OF SAUK 5 6 Intergovernmental Agreement Contract #13704 was awarded to the County of Sauk for \$40,000 to share costs for completion of survey, hydrologic and hydraulic analysis and preliminary 7 8 design for the proposed Great Sauk-Walking Iron Trail bridge over the Wisconsin River. 9 Dane County and the County of Sauk amended the Master Agreement on July 26th, 2021 10 through Addendum A in order to extend the term of the contract to December 31, 2022, and to 11 equally share consultant costs with the County of Sauk to complete an additional river bed 12 13 geotechnical boring necessary for future planning and construction of the bridge at an additional 14 cost of \$72,977.50. 15 16 Dane County and the County of Sauk wish to amend the Master Agreement in order to extend the term of the contract to December 31, 2025, and to equally share consultant costs with the 17 County of Sauk to complete construction documents, regulatory permits, bid and construction 18 administration services for future construction of the bridge at an additional cost of \$700,000 to 19 20 Dane County (total estimated cost of \$1,400,000). 21 22 NOW, THEREFORE, BE IT RESOLVED, that Intergovernmental Agreement Addendum B be 23 awarded to the County of Sauk in the amount of \$700,000 and to extend the contract through 24 December 31, 2025. 25 BE IT FINALLY RESOLVED that the County Executive and County Clerk are hereby authorized 26 27 and directed to sign the agreement on behalf of Dane County.

#### DANE COUNTY CONTRACT ADDENDUM

**THIS ADDENDUM**, made and entered into effective as of the date by which both parties hereto have executed this document, by and between the County of Dane (hereinafter referred to as "County") and Sauk County (hereinafter, "Provider").

#### WITNESSETH:

WHEREAS County and Provider, by a separate document (hereinafter, the "Master Agreement"), Dane County Contract # 13704, have previously entered into a contractual relationship pursuant to which Provider agreed to share consulting costs for survey, hydrologic and hydraulic analysis and preliminary structural design for the proposed Great Sauk State-Walking Iron Trail Bridge across the Wisconsin River; and

WHEREAS County and Provider amended the Master Agreement on July 26th, 2021 through Addendum A in order to extend the term of the contract to December 31, 2022, and to equally share consultant costs with the Provider to complete an additional river bed geotechnical boring necessary for future planning and construction of the bridge at an additional cost of \$72,977.50.

WHEREAS County and Provider wish to amend the Master Agreement in order to extend the term of the contract to December 31, 2025, and to equally share consultant costs with the Provider to complete construction documents, regulatory permits, bid and construction administration services for future construction of the bridge at an additional cost of \$700,000.00 to Dane County.

**NOW, THEREFORE,** in consideration of the above premises and the mutual covenants of the parties hereinafter set forth, the receipt and sufficiency of which is hereby acknowledged by each party for itself, the parties do agree as follows:

- The Master Agreement shall remain in full force and effect unchanged in any manner by this addendum except as changes are expressly set forth herein. This addendum shall control only to the extent of any conflict between the terms of the Master Agreement and this addendum.
- 2. The term of the contract is extended through December 31, 2025, at an additional cost of \$700,000.00 to Dane County.
