# Policy Analysis Statement:

#### Brief Description of Proposal -

This proposal authorizes the County to accept grant funding in the amount of \$132,211 from the Wisconsin Department of Justice (DOJ), Byrne Memorial Justice Assistance Grant Program, Drug Task Force, Grant Number 2020-DJ-01-17060, for continued participation in the Dane County Narcotics Task Force, to support overtime costs for members of the task force and for collection of data and information, as required. Funds will also be used to support a Dane County ADA position with job responsibilities to include drug court diversion practices.

Current Policy or Practice -

Acceptance of grant funding requires County Board approval.

Impact of Adopting Proposal -

As the opioid epidemic continues nationwide, the Dane County Sheriff's Office recognizes the need for cooperation and coordin ation of drug enforcement efforts with state and local counterparts. This cooperation provides several advantages including the ability to draw on the expertise of state and local law enforcement partners and the ability to share resources and expenses thereby increasing the investigative possibilities available to all.
