# 2. Friends Capital Improvement Grant Project Award - FOPBC

The Friends of Pheasant Branch Conservancy submitted a grant request for \$5,559 to install a permanent limestone edging border to their native plant propagation garden located in the Conservancy.

1. Town of Albion, Conservation Fund Grant Application - Lake Koshkonong public access

Bob Venske and Larry Beck provided background on a proposed new lake access facility on the north shore of Lake Koshkonong in the Town of Albion. There are currently no other public landings on the entire north shore of the lake. The lake is used extensively for fishing, waterfowl hunting, ice fishing, boating and wildlife observation. The Town recently purchased 2.1 acres of land on the west side of Bingham Road for the purpose of creating the new lake access facility that will include car and trailer parking, picnic area, boat ramp and breakwater. The Town has requested a grant of 50% of the total acquisition costs, approximately \$36,200, which will be considered for approval by the Park Commission at a future meeting.

2. PARC & Ride Grant Program 2022

James provided an overview of four pending PARC and Ride grant requests that are being considered for approval in 2022. The projects are carry forwards from the 2021 grant application period and include a bicycle playground in the City of Fitchburg, skills and pump track trails in the City of Madison, a regional trail connection to the Military Ridge State Trail in the City of Verona and a connector trail between the Glacial Drumlin State Trail and McCarthy County Park in the Village of Cottage Grove.
