## Policy Analysis Statement:

## Brief Description of Proposal -

Dane County Department of Human Services, Prevention \& Early InterventionDivision provides localized services in communities identified as needing those services the most through the Joining Forces for Families Program (JFF).

This resolution authorizes Dane County to enter into a Lease with the DeForest Area Community and Senior Center.
