# AFFIRMING THE 2021 AFFORDABLE HOUSING DEVELOPMENT FUND AWARDS **DCDHS - HAA DIVISION**

#### Policy Analysis Statement:

#### Brief Description of Proposal -

Dane County Department of Human Services (DCDHS) Housing Access and Affordability (HAA) plans to award funding to seven projects from the 2021 Affordable Housing Development Fund (DCAHDF) to support the creation of 465 units of affordable housing. The fund had \$8,286,801 to award through an application process in 2021.

Review of the applications resulted in award recommendations to the following projects:

(A) \$1,450,000 to MSP Real Estate, Inc.

(B) \$1,310,000 to Lincoln Ave Capital

(C) \$640,000 to Northpointe Development II Corporation

(D) \$1,260,000 to Northpointe Development II Corporation

(E) \$1,510,000 to Habitat for Humanity of Dane County

(in conjunction with Northpointe Development II Corporation and DreamLane Real Estate Group)

(F) \$860,000 to Odessa Affordable Housing, LLC

(G) \$1,256,801 to MWF Properties, LLC

#### Current Policy or Practice -

Authorizing submission requires Board approval.

### Impact of Adopting Proposal -

Individual project funds will be granted to the Dane County Housing Authority (DCHA) that will then loan funds to project developers pursuant to the executed Memorandum of Understanding between Dane County and the Dane County Housing Authority. Resolutions specific to each individual project will be forwarded to the County Board to approve documents related to the financing structure of each individual project.
