Subcommittee Goals and Objectives

Goff likes the current structure and sees commission as go between of subcommittees doing work and commission touching County Board. Thinks at least one subcommittee should remain. There was once a need for both subcommittees, but most services are no longer volunteer. Patrick Anderson mentions ALS which is part of IGA. Many committees were created over the years as needs arose, but the lines are now blurred. Wunsch asks members to consider if combining committees would create too large of a workload. Russell feels like more has been accomplished from weekly EMS Chiefs meetings hosted by DCEMS office than the committees since Covid has started. Agreement that virtual meetings have allowed more people to participate. Lang discusses historical issue of meeting quorum on committees. Meier reviewed EMS Commission ordinance and confirms subcommittees are not written into ordinance and are in control of EMS Commission. Meier reiterates idea expressed at the Medical Advisory Subcommittee meeting of creating one Commission Advisory Subcommittee, combining the two. Patrick Anderson and Scott Bavery expressed support of this idea. Next step is to share conversations had at subcommittees to EMS Commission for further discussion.
