AUTHORIZING AN AGREEMENT FOR GRANT FUNDING TO PURCHASE RAPPELLING GEAR FOR THE SHERIFF'S OFFICE TACTICAL RESPONSE TEAM

#### Brief Description of Proposal -

The Homeland Security (HS) – Wisconsin Emergency Management (WEM), Department of Military Affairs (DMA) is providing \$4,000 grant funding to the Sheriff's Office Tactical Response Team (TRT) to purchase rappelling gear; Grant Number 2021-HSW-02A-12726, funding is available November 15, 2021 through June 30, 2022.

# Current Policy or Practice -

Acceptance of grant funding requires County Board approval.

### Impact of Adopting Proposal -

Rappelling provides an option to descend multi-pitch routes, offers a quick way to descend, and is simple to set up. This grant funding will allow the Dane County Sheriff's Office TRT to purchase new safety harnesses and related equipment to conduct high angle rescue and will enhance TRT capabilities in high risk incidents within the eleven county emergency response region area in which the TRT operates.
