2. Description of the Initial Appearance Process

Presented by Clark-Bernhardt

Presentation regarding the full Criminal Justice Council's work on pretrial justice initiatives, including a visualization of the system process and decision-making points. Discussion of different "off-ramps" to exit the criminal justice system early in the process. Discussion of initial appearance (IA) processes, including transition to virtual IA hearings due to COVID. Invitation to subcommittee members to watch IA proceedings remotely to learn more about the process. Discussion about data collection in pretrial justice, including the Public Safety Assessment (PSA) risk assessment tool.

Discussion of behavioral health services, family access to support, and victim support services at the IA stage occurred. There are barriers to accessibility in place that create challenges when family members aim to provide support. A more systematic process would enable connection to services. There is a feasibility study on a mental health court right now, structured as a post-charge diversion program following guilty plea, as a condition of deferred prosecution.

3. Intercept 2 (Initial Detention & Initial Appearance) and Discussion and Next Steps

Review of subcommittee members' survey results about priorities in intercept 2 on initial detention and initial appearance. Discussion of what research has been completed on existing programs, in addition to what resources have been implemented in Wisconsin. Discussion on the experiences of people with lived experience and operationalizing peer support in pretrial services and initial processes. These services could focus on people who are potentially screened or identified as living with a mental health condition. Additional system-mapping can focus on identifying what resources are serving which populations and target peer support accordingly. Discussion of the potential pilot of the Brief Mental Health Screener in the jail. Discussion of limited capacity among stakeholders. Discussion regarding use of existing data and additional data collection. Challenges with self-report data regarding mental health in the criminal justice system, both for jail housing and for 5th Amendment right against self-incrimination. It would be easier and preferable to calculate the aggregate number of people with mental health conditions in the jail and other stages of the criminal justice system, rather than focusing on identifying individual people. Discussion on implementing peer support services. Overall resources can be targeted and focused based upon the data.
