Policy Analysis Statement:

Brief Description of Proposal -

The 2020 Dane County Capital Budget awarded funding of \$1,300,000 to The Salvation Army, also known as its affiliate Shield Apartments, LLC, for Shield Apartments, an affordable housing project to be constructed at 651 East Mifflin Street in the City of Madison.

The project will consist of 44 units. All units will be affordable.

Current Policy or Practice -

Real estate agreements require approval of the County Board.

Impact of Adopting Proposal -

The County's support includes a grant from the County to the Dane County Housing Authority. The Housing Authority will then make a loan to the project owner. The terms of the loan include interest only payments of 1% for a 40 year term. The principal of the loan will be due to the housing authority at the end of the loan.
