CREATING NEW REVENUE AND EXPENDITURE LINES FOR FUNDS FROM THE STATE OF WISCONSIN DEPARTMENT OF HEALTH SERVICES DCDHS - ACS DIVISION

Policy Analysis Statement:

Brief Description of Proposal -

On February 3, 2022 the County Board adopted 2021 Res-295 accepting American Rescue Plan funds that were added to Older Americans Act funding from the Wisconsin Department of Health Services These additional funds were effective October 1, 2021 and are available through September 30, 2022.

A portion of these funds will be used to provide meals for older adults (age 60 and older) who are in the community and at risk of malnutrition and to provide additional support to family caregivers.

This resolution will authorize the use of these funds in two additional ways. The first will be to secure intensive supportive home chore services to assist in cleaning and organizing homes or apartments that are hoarded or unkempt to the degree that it impacts their ability to live safely in the community. The second additional use of funds will be to address isolation and malnutrition by providing additional bus service for the Fitchburg Senior Focal Point.
