Contract #85475 - Programs #13547 & #13548

These programs provide payment for preauthorized, voluntary and involuntary, psychiatric inpatient hospital stays at Miramont Behavioral Health. This contract pays per day of service and negotiates the rate directly with the facility on an annual basis. Average length of stay under the contract is three (3) days. The County's Emergency Mental Health Services provider (under DHS 34), Journey Mental Health Center, is the only agency allowed to authorized a stay under this contract and does so using clinical judgment of the client's presentation. Journey Mental Health Center also oversees the stay and ensures authorizations do not exceed contracted amount of days.

All local hospitals are under contract for this service. If an RFP were to go out, there would likely be no response as local hospitals provide this service a fairly reduced rate. An RFP would also mean less ability for DCDHS to contract with each hospital and end up reducing local options for inpatient psychiatric stabilization. In turn, the County may see an increase in emergency detentions and unnecessary trips to Winnebago Mental Health Institute. Providing an opportunity to each of our local hospitals with psychiatric units a chance to contract with Dane County Department of Human Services is why we do not feel a competitive bidding process would be appropriate. Also, the strict prior authorization process further ensures justification for keeping this service outside of our normal RFP process.
