Policy Analysis Statement:

Brief Description of Proposal -

The Sheriff's Office requests the creation of revenue and expenditure accounts to establish the capacity for the Sheriff's Office to accept monetary and non-monetary donations from private and public sources to support the Sheriff's Office Peer Support Team.

Current Policy or Practice -

Acceptance of donations and the establishment of expenditure/revenue accounts requires County Board approval.

Impact of Adopting Proposal -

The Sheriff's Office will be authorized to accept donations and use these donations to assist co-workers during times of both professional and personal crisis through the use of specially trained volunteer peers. Peer support is a vital component of maintaining the health and wellness of staff in the Sheriff's Office.
