Silverwood County Park Master Plan Update

*Hicklin gave a general overview of the draft master plan concepts for Silverwood County Park and noted that staff are currently working with the Friends of Silverwood on a lease for a portion of the park. The lease will require review by the Commission when it is further along.*

### Indian Lake County Park Current Projects Update

*James gave a brief update on the ongoing effort to remove carp from Indian Lake. The lake was chemically treated in 2015 in an attempt to eradicate carp. More carp survived than was anticipated (weather conditions at the time of the treatment unexpectedly led to a thaw, which diluted the treatment), and therefore additional efforts to reduce the remaining population are under consideration. It's unlikely that the lake will be chemically treated a second time. Additionally, James reviewed plans to build a new timber frame shelter and related improvements at the park.*
