AUTHORIZING A CONTRACT BETWEEN DANE COUNTY AND SMART COMMUNICATIONS HOLDING, INC. FOR DANE COUNTY JAIL RESIDENT TELEPHONE AND VIDEO VISITATION SERVICE

**Policy Analysis Statement:**

Brief Description of Proposal -

Request approval to award a contract to Smart Communications, Inc., for provision of jail resident telephone and video visitation service, resident tablet service, and mail scanning service, commencing on November 1, 2025 and continuing for five (5) years.

Current Policy or Practice -

Dane County engaged in a competitive bidding process for a vendor to provide jail telephone and video visitation service to residents in the Dane County Jail, 2025 RFP-019.

Impact of Adopting Proposal -

Jail resident telephone and video visitation keeps families connected during times of incarceration and although in-person visitation is available as a primary mode of visitation, video visitation supplements in-person visitation and provides residents and their families an additional option to connect.
