

American Rescue Plan (ARP) Status & Outcome Report

Quarter 4 2024

Emergency Rental Assistance

Status:

A resolution was approved by the County Board on May 19, 2022 to award Tenant Resource Center \$1 million in direct assistance resources for the community through their Eviction Defense and Diversion Project (EDDP). The program is funded by federal emergency rental assistance (ERA 2) dollars provided to Dane County in 2021.

A resolution accepting an additional \$27 million in ERA 2 was passed by the Dane County Board on October 19, 2022. The resolution also awarded additional funding the Tenant Resource Center to continue their contribution to the EDDP.

Outcomes: The data metrics stated in the resolution, as required by the U.S. Treasury, are below for 2024 Q4 for EDDP, administered by the Tenant Resource Center, in partnership with several legal defense organizations.

Doubled Up Housing Pilot

Status: RES-187 and RES-186 were passed on November 6, 2023, awarding contracts to WayForward Resources and Urban Triage, respectively, to administer a housing program for households experiencing homelessness who are doubled up (self-paying in a hotel/motel or living with others and not named on a lease). The program is funded by Dane County's ERA allocation referenced above. The data for the Doubled Up Housing Pilot is a duplicative subset of the Emergency Rental Assistance data.

Outcomes: The data metrics stated in the resolution, as required by the U.S. Treasury, are below for Q4 2024.

*Data separate from HMIS: NOT included in the enrolled were 40 households before 01/01/22 & not entered into HMIS. Many of these households resided at the Vulnerable Population Hotel (VPH), received H2H enrollment, but were not engaged or interested therefore were not housed with exit destinations that were not recorded in HMIS. This data reflects an 85% housing placement rate (291/341) at least at one point while enrolled in the program. There was a 26.5% non-renewal rate, and 62% of those non-renewed clients were rehoused.

Number of months of direct assistance and case management services provided per household by program end date = 17.4 months.

Homeless Outreach Services

Status: RES-115 was passed on August 18, 2022 awarding a contract for Catalyst for Change to provide Homeless Outreach services to unsheltered Dane County residents outside of the City of Madison. The program ended on December 31, 2024.
