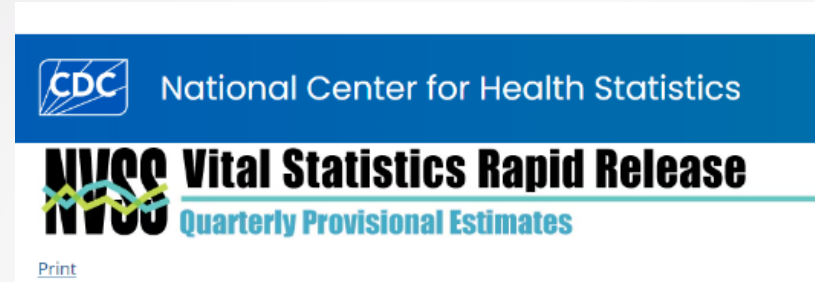

Hospital Alters Conclusions in Patient Death

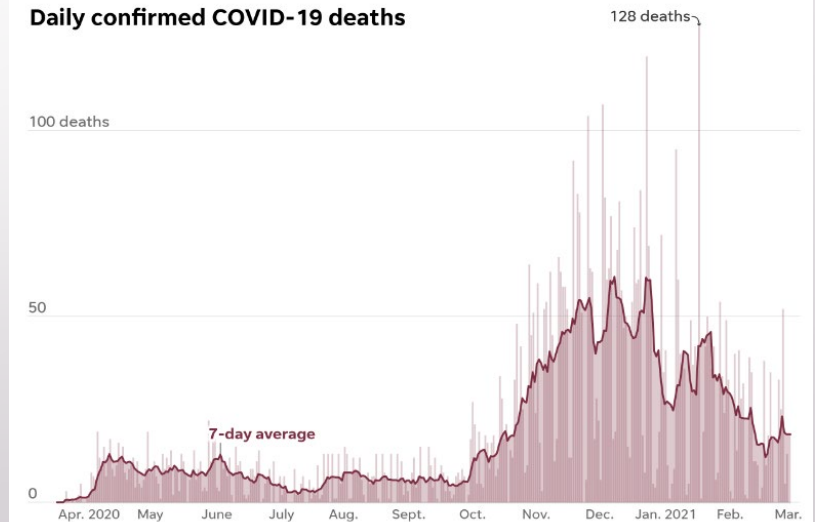

Days after NewYork-Presbyterian/Columbia Hospital said that a patient's death last month had not been caused by Legionnaires' disease, it reversed itself yesterday, saying that an autopsy showed that the disease had indeed led to the death. The hospital also said that the bacteria associated with the disease were found yesterday at a large inpatient center that it operates more than 100 blocks from the building where the case occurred.

In a formal statement yesterday, the hospital said that the disease was the "primary factor" in the death of the patient, whose identity it would not disclose, at its Milstein Hospital building in Washington Heights. It also said that the bacteria had been detected in the water supply of its Greenberg Pavilion at the NewYork-Presbyterian/Weill Cornell hospital, on the Upper East Side.

The hospital said it had no idea why the two buildings' water supplies, both provided by the city's water system and routinely treated to kill the bacteria,

Role of the Coroner/Medical Examiner

- Tissue Donation

Uniform Anatomical Gift Act; 1998:

- All hospitals must have a relationship with an Organ Procurement Organization (OPO)
- Allows families to make *informed* decision at the end of life



Role of the Medical Examiner -Assisting the Family

- Discuss the autopsy procedure
 - Understanding need and extent
 - Understanding respect towards the decedent
 - Objections/requests
- Social services/support groups
- Timeline of procedures, “next steps”
- Media release



County Executive Requirements

- No additional reliance on GPR beyond personnel and contractual costs
- Apply revenue to any shortfall of GPR in other expenditure lines
- Limited capital spending
- Increase revenue

MEDX 1– Adjustment to Personnel and Operational Budget expenses

- Adjustment to more accurately reflect expenses
- Increase of \$97,169 (revenue) to meet budget needs:
 - Overtime, Limited Term Employees, Pre-employee Physicals
 - Salary increases (COLA)
 - Longevity credits
 - Holidays/accrued vacations – increase with staff retention



MEDX 2-Contractual Obligations

- NMS (Toxicology)
 - 3% - increase in cost in 2025; increasing complexity of cases and novel substances
- St. Mary's Hospital (SSM) Testing-
 - Department of Public Health (DPH)/ Wisconsin State Laboratory of Hygiene (WSLH) no longer accepting postmortem samples, except to confirm/determine cause of death; required to pursue permission from DPH for each other case
 - \$100 per COVID test
- Conveyances – Funeral Home transportation to morgue
 - 5% cost increase per transport following contract-based service

MEDX-3 Cremation Permits

- Conservatively estimate increase of 116 paid cremation permits
 - Wisconsin Funeral and Cemetery Aids Program (WiFCAP)

- Cremation continues to rise in popularity as means of final disposition
- New ecologically sound cremation methods (“flameless cremation”, “chemical cremation”) is expected to attract more families in future
- WiFCAP-State funded assistance program; fee waiver for qualified applicants

Anticipated 2025 revenue: \$40,453

MEDX-3 Cremation Permit Fee Increase

- Increase fee by \$12
- Anticipated revenue increase \$45,630.00
- Work with PP&J to propose an ordinance amendment for this increase
- Anticipated **increase** : \$86,083
- \$59.36 enacted in 2015
- Allows a fee increase based on the increase or decrease in CPI (consumer price index)
- Per § 979, deaths must be investigated before cremation permit
 - Documentation of injuries, recent surgical procedures, medical record review and follow-up, physician case review
 - Ensure accuracy of death certificate data
 - Associated costs of travel to funeral homes, wages, personal protective equipment (PPE), mileage, vehicle and equipment expenses

MEDX-4 Adjustments to Rock County Intergovernmental Agreement (IGA)

- IgA adjustment resulting in a base **increase** of \$11,085 dollars
- Minor adjustments to revenue – admin salary, physician
 - COLA increase
 - Doctors salary & administrative oversight

Summary

- Meet the 2025 Budget Guidelines:
 - No increase in general purpose revenue outside personnel and contractual obligations
 - With ordinance amendment will increase revenue
 - Revenue applied to other expenditure lines
 - No new capital improvements
