1. West High School Civics Club Voting Initiative

The Civics Club is partnering with the Dane County League of Women Voters in an attempt to garner statewide support from the organization for advocating for a constitutional amendment that would lower the voting age to 16 in Wisconsin school board elections

The Civics Club also plans to seek resolutions of support from the Madison Metropolitan School Board and the Madison Common Council as well as school boards around Dane County.

The Civics Club representative said she would work with a Supervisor to draft a resolution of support to present to the Dane County Board of Supervisors.
