Brief Description of Proposal -

Homeland Security (HS), Wisconsin Emergency Management (WEM), Department of Military Affairs (DMA), is providing grant funding of \$15,000 to support the Aligned Law Enforcement Response Team (ALERT) Hazard Devices Unit (HDU), Grant Number 2022-HSW-02A-13102, to provide for the purchase of specialty equipment required by bomb technicians when dealing with hazardous devices.

Current Policy or Practice -

Acceptance of grant funding requires County Board approval.

The purchase of bomb technician response equipment is required to provide HDU members with the necessary tools required to safely and effectively deal with hazardous, highly volatile situations in order to safely detonate and dispose of the explosive devices.
