*Olson stated that during Senior Advocacy Training this month, she and Erin Fabrizius, a member of NewBridge Madison's Board of Directors, spoke about forming a group to raise the profile of individuals providing advocacy efforts on behalf of Dane County seniors. The group, which Olson and Fabrizius suggest be called "The G-Force," would wear gray T-shirts when appearing at meetings and hearings in an advocacy role. Olson volunteered to write a letter to Focal Point Directors and the county aging network seeking volunteers to join the effort.*

*AAA Manager Cheryl Batterman provided an overview of the Senior Advocacy Training evaluations and shared several examples of advocacy efforts that have appeared in Focal Point newsletters since the training session on 8 August 2019.*

### 2. 2020 AAA BUDGET PRIORITIES

*Batterman reported the Dane County Department of Human Services (DCDHS) budget is scheduled to be released Friday. She will notify committee members when it is posted. AAA staff members are unable to discuss the budget until after its public release. Batterman will ask Focal Point Directors to rank the previously identified budget priorities should advocacy efforts be required. The DCDHS budget hearing is scheduled for 11 September 2019 at Warner Park Community Recreation Center.*

### 3. ADRC GOVERNING BOARD

### 4. COUNTY/STATE/FEDERAL LEGISLATIVE UPDATE

*Dane County Legislative Liaison Carrie Springer announced the Dane County 2019-2021 Legislative Agenda has been approved; she will provide copies via email.*

### 5. STATE'S AGING ADVISORY COUNCIL

*Olson reported the Council recently undertook two advocacy efforts – one involving personal care workers oversight and the other aimed at getting more Wisconsin counties to use biodegradable products for their nutrition programs. The meeting on 1 August 2019 was held in Green Bay and included a tour of the Oneida Nation's Elder Services Building.*

## 7. CHAIR & STAFF REPORTS

*Batterman reported she met recently with a U.S. Census Bureau Field Representative, who shared that seniors fall into seven of the 10 groups of people the Census Bureau has identified as the most difficult to count. Batterman is working with a Dane County Census Committee and plans to encourage Focal Points to educate seniors about the importance of participating in the census, which is used to determine federal and state funding levels. AAA uses census and American Community Survey data as part of funding formulas for the Case Management Program and Senior Nutrition Site Management. Residents will receive a letter encouraging them to complete the census form online and Batterman will encourage Focal Points to provide internet access for older adults without it.*

*Batterman has participated in two national conference calls regarding the Mental Health Access Improvement Act of 2019 (Senate 286, HR 945), which seeks to expand coverage of mental health services under Part B of Medicare. Specifically, the bill would amend the Social Security Act to increase access to mental health services by permitting Licensed Professional Counselors and Licensed Marriage and Family Therapists to be reimbursed by Medicare. Batterman will ask the Wisconsin Aging Advocacy Network (WAAN) to support the legislation, which would be especially beneficial to underserved residents in rural areas.*

*Batterman reported preparations continue for an event at the State Capitol with the intent of educating state lawmakers about the impact of the Elder Benefit Specialist (EBS) Program and securing increased state funding. Daniel Idzikowski, Program & Policy Coordinator at Milwaukee County Department on Aging, WAAN Advocacy & Public Policy Coordinator Janet Zander, Wisconsin Association of Benefit Specialists Legislative Committee Co-Chair Tiffany Scully, and Greater Wisconsin Agency on Aging Resources (GWAAR) Legal Services Manager Kate Schilling are working with Batterman to stage the event, which is tentatively scheduled for February. A form has been distributed to each county to collect data and anecdotal evidence of the program's impact. The effort was spawned by Batterman's realization during Aging Advocacy Day in May that state lawmakers and staff appeared to possess little knowledge about the EBS Program when participants shared the WAAN Issue Brief calling for increasing State funding to ensure continued access to legal advocacy services for Wisconsin's fastest-growing population. The State hasn't increased its funding of the EBS program in the past 22 years.*
