Personal and Finance Committee Chair Sup. Paul Rusk had contacted Dane County Director of Human Services Lynn Green about creating a Resolution for a jail study at the November 25th PP&J meeting.

3. 2015 Budget Update - Sup. Wegleitner, Sup. Krause and Sup. Ritt

Sup. Wegleitner announced that County Executive Parisi has signed the 2015 budget. Green announced that the 2015 Department's budget is over \$266 million. The County Board added in Human Services an additional \$35,000 to Briarpatch for a Homeless Youth Shelter, \$25,000 to Jewish Social Services for Immigrant Services, \$50,000 to Bethel Day Services \$5,000 to The Road Home for housing case management, and funding to restore half of the GPR reduction to the Adult Developmental Disabilities system.

G. Future Meeting Items and Dates

HSB members were encouraged to come up with a list of recommendations they would like to discuss for the 2015 work plan. Murray suggested that the Board look into addressing the amount of children living in poverty in Dane County. Members asked DCDHS staff to contact Catholic Charities about bringing in a staff member to present at the next meeting, regarding the School Board Mental Health Initiative.

The next HSB meeting will be on January 15th at 5:30.
