#### G. Manager's Report

##### 1. ILSP Update

Fischer provided an update on the pilot program that provides \$7200 to people who are at 300% poverty level or below. The State had extended people enrolling in it until the end of June. Fischer stated because of staff turnover and the amount of time it takes to fill the positions, we will not be able to meet 1068 people being enrolled as planned.

##### 2. ADRC Operations Update

Fischer said one of the Disability Benefit Specialist was hired for the part-time Transportation position. The full-time Disability Benefit Position now needs to be filled. The Disability Benefit Specialists are very busy with high case loads. Fischer said a past Supervisor is coming in to assist as a part-time LTE.

Fischer mentioned that the operations of the ADRC are as normal.
