BUDGET ACCOUNT LINE ADJUSTMENTS REQUIRED FOR SHERIFF'S OFFICE SEATBELT ENFORCEMENT PROJECT

Policy Analysis Statement:

Brief Description of Proposal -

2015 RES-472 authorized acceptance of \$120,012 in grant funding for a seatbelt enforcement collaborative effort with the Sheriff's Office and Madison Police Department. 2015 RES-472 was adopted by the County Board, March 17, 2016 and the grant agreement was signed by the County Executive March 28, 2016. An adjustment to budget account lines, as authorized by 2015 RES-472, is required to allow the Sheriff's Office to reimburse seatbelt enforcement efforts that are accomplished by the Madison Police Department for this project; of the tot all grant award the Sheriff Office will receive \$60,006 and the Madison Police Department will receive \$60,006.

Current Policy or Practice -

Authorizing budget amendments requires County Board approval.

Impact of Adopting Proposal -

During 2014 in Wisconsin, 51% of persons killed and 24% of persons sustaining incapacitating injuries were not wearing seatbelts; many of these individuals were ejected from their vehicles. Seatbelt use in Wisconsin is approximately 6% lower than the national average. A sustained high-visibility enforcement effort is a proven effective countermeasure in changing driver behavior and increasing seat belt use. Increasing seatbelt use will save lives, prevent injuries on Dane County roadways, and positively impact health and safety of citizens in the community.
