Presentation on the behavioral health needs assessment by PCG (Public Consulting Group). Presentation covered data collection and methodology, prevalence rates of mental health conditions, rate of service access and utilization, continuum of care, wait times, racial disparities based on Dane County data (not private insurance/Medicaid), intersection with law enforcement, examination of jail data, restorative justice options, potential services offered by a crisis restoration center.

Recommendations: maximize capacity; formalize partnerships; develop additional services; improve access for underserved populations; increase diversion options; extend crisis response to rural areas; create infrastructure for data-driven decision making across sectors.

Discussion by committee members regarding potential study of a mental health court, CIT training across more jurisdictions within Dane County, the creation of a universal access call center, and a work group to examine data sharing in mental health services. Questions regarding where the competency process falls into the Sequential Intercept Model were raised.
