AUTHORIZING A CONTRACT FOR REIMBURSEMENT FOR COMPETENCY RESTORATION TREATMENT PROVIDED TO DANE COUNTY JAIL RESIDENTS

Policy Analysis Statement:

Brief Description of Proposal -

Request approval of a contract with the Wisconsin Department of Health Service (DHS) to provide reimbursement for treatment to competency service, provided by the County, to designated residents in the custody of the Dane County Jail who have been determined by the Court to be not competent to proceed to trail but are likely to become competent if treatment is provided.

Current Policy or Practice -

Contracts in excess of \$100,000 require County Board approval.

Impact of Adopting Proposal -

Competency restoration is the process used when an individual charged with a crime is found by a court to be incompetent to stand trial, typically due to an active mental illness or an intellectual disability. A criminal defendant must be restored to competency before the legal process can continue. Restoration is effected by providing inpatient mental health treatment and education to allow the defendant to regain competence and proceed to trail.
