Motion: (revenue/expenditure/text effect)	Neither expenditures nor revenues be changed and the following language be added to 2017 RES-253, "Prior to investment in the biogas offloading station for the CNG pipeline, agreements between Dane County and each digester owner interested in using the pipeline be in place and reviewed by the Public Works and Transportation Committee and the Personnel and Finance Committee in order to insure that the pipeline capacity is sized appropriately for the demonstrated digester demand. "		
Program Effect:	The provision requires a commitment by digester owners to use the pipeline before the county invests \$5.5 million to build it.

Intent/Justification			
<p>The goals of the biogas offloading station are to strengthen the agricultural economy and protect water quality, as well as to reduce greenhouse gas emissions and advance domestically produced alternative fuels. Digester owners would need to take steps required to ready methane for the pipeline and truck it to the offloading station site. Prior to investing \$5.5 million in building the offloading station, digester owners should sign an agreement indicating their intent to use the pipeline, including a timeline and estimated volume of CNG to be injected into the pipeline. This will allow the county to make an informed decision regarding the capacity of the biogas offloading station.</p>
