AMENDING CHAPTERS 45, 46 & 47 OF THE DANE COUNTY CODE OF ORDINANCES,
ADJUSTING FEES CHARGED BY PUBLIC HEALTH AND CORRECTING ADMINISTRATIVE
CODE REFERENCES

The County Board of Supervisors of the County of Dane does ordain as follows:

ARTICLE 1. Unless otherwise expressly stated herein, all references to section and chapter numbers are to those of the Dane County Code of Ordinances.

ARTICLE 2. Section 45.51 is amended to read as follows:

45.51 FEE SCHEDULES.

- (1) The fee for a well siting permit shall be \$~~100~~188.00.
- (2) The fee for a transfer of a well siting permit shall be \$42.00.
- (3) The fee for a re-inspection of a well site shall be \$~~32~~123.00.

ARTICLE 3. Section 46.03(5) is amended to read as follows:

- (5) *Food* shall have the meaning given in chapter ~~DHS-196~~ATCP 75 of the Wis. Admin. Code.

ARTICLE 4. Section 46.03(16) is amended to read as follows:

- (16) *Restaurant* shall have the meaning given in chapter ~~DHS-196~~ATCP 75 of the Wis. Admin. Code.

ARTICLE 5. Section 46.21(1) is amended to read as follows:

46.21 FACILITIES REGULATED.

(1) Restaurants, public swimming pools and water attractions, beaches, campgrounds, hotels, motels, recreational and educational camps, tourist rooming houses, bed and breakfasts; retail food establishments, manufactured home communities; wells; servicing of septic tanks, seepage pits, grease traps or privies; and vending machines shall be constructed, operated, performed and maintained in accordance with chapters ~~DHS 195~~ATCP 72, DHS-196, DHS-197ATCP 73, DHS-198, DHS-172ATCP 76, DHS-175ATCP 78, DHS-178ATCP 79, ATCP 75, SPS 390, SPS 326, NR 812, NR 113 and NR 845 of the Wis. Admin. Code, as appropriate. Each facility identified herein shall be considered a regulated facility under this chapter.

ARTICLE 6. Section 46.23 is amended to read as follows:

46.23 FEES.

(1)(a) The county fee for each inspection block required for the installation of a POWTS shall be \$~~184~~199.00. Inspection blocks for POWTS will be assigned according to the following:

- 1. A POWTS system reconnection, septic tank or pump chamber only, a repair of an existing POWTS system, a process or activity intended to restore the absorptive capacity

47 of the soil treatment or dispersal surface, or similar technologies, requires a 0.71
48 inspection block for the installation or process inspection.

49 **2.** A holding tank, a gravity fed or dosed below grade soil treatment POWTS system
50 that does not include any other treatment or dispersal component, or similar technology,
51 requires one inspection block for the system installation.

52 **3.** A POWTS system incorporating pressurized in-ground soil treatment or the repair
53 or reconstruction of an existing mound, requires 2 inspection blocks for the system
54 installation. This subsection shall not apply to a drip line effluent dispersal component.

55 **4.** A single pass sand filter, recirculating sand filter, split bed sand filter or similar
56 technology requires 4 inspection blocks for the system installation.

57 **5.** A POWTS system incorporating a pressurized mound, any at-grade mound, a drip-
58 line effluent dispersal component, or similar technology, requires 4 inspection blocks for
59 the system installation.

60 **6.** A nonpressurized POWTS system incorporating chemical or mechanical treatment
61 or disinfection component(s) with discharge into a soil treatment or soil dispersal
62 component or similar technology requires 2 inspection blocks for the system installation.

63 **7.** A system component authorized in Ch. SPS 391, non-plumbing sanitation units
64 (NPSU) or similar technology requires 1 inspection block for installation of the
65 component.

66 **8.** A POWTS system that utilizes a technology that is added to the approved system
67 list under s. SPS 383.61 after July 1, 2000 shall require the number of inspection blocks
68 included as part of the approved system design, approved system package or the number
69 of inspection blocks necessary to provide adequate assurance of proper installation as
70 established in procedures approved by the Dane County Board of Health.

71 **9.** A POWTS system that incorporates a design for wastewater discharge less than
72 2,000 gallons per day shall qualify for a county fee equal to the sum of the permit review
73 and processing fee plus the associated inspection block fee.

74 **10.** A POWTS system that incorporates a design for wastewater discharge between
75 2,001 and 12,000 gallons per day shall qualify for a county fee equal to the sum of the
76 permit review fee plus the associated inspection block fee plus one additional inspection
77 block fee for each 2,000 gallon per day increment in wastewater discharge.

78 **(b)** The county fee for the review and processing of a sanitary permit application shall
79 be assigned according to the following:

80 **1.** The county fee for review and processing of a sanitary permit application for a
81 POWTS system reconnection, septic tank/pump chamber only, repair of existing POWTS
82 system, a holding tank, a gravity fed below grade soil treatment POWTS system that
83 does not include any other treatment or dispersal component, a system component
84 authorized in Ch. SPS 391, non-plumbing sanitation units, or other similar technologies
85 or activities shall be ~~\$428~~141.00.

86 **2.** The county fee for review and processing of a sanitary permit application with a
87 POWTS design incorporating a drip line effluent dispersal component, aerobic treatment
88 unit, dosing apparatus not connected to a pressurized distribution network or similar
89 technology shall be ~~\$450~~165.00.

90 **3.** The county fee for review and processing of a sanitary permit application with a
91 POWTS design incorporating a pressurized distribution network shall be ~~\$472~~189.00.

- 92 4. The county fee for review and processing of a sanitary permit application with a
93 POWTS design incorporating a component claiming nitrate reduction credit, chemical or
94 mechanical sewage treatment credit, sewage discharge disinfection credit or any
95 treatment component that will allow final discharge into soil that is not intended to be part
96 of the final sewage treatment process shall be ~~\$270~~297.00.
- 97 5. The county fee for review and processing of a sanitary permit application with a
98 POWTS design incorporating a technology that is added to the approved system list
99 under s. SPS 383.61 after July 1, 2000, shall be ~~\$150~~165.00 in addition to the fee for the
100 review and processing category closest to the POWTS design the technology is
101 incorporated into.
- 102 (2) Fees for the issuance or renewals of sanitary permits shall not be reduced below
103 the sum specified by s. 145.19(2), Wis. Stats., or acts amendatory thereto.
- 104 (3) There shall be a county fee of ~~\$452~~167.00 for the transfer of permits under section
105 46.08(5), when such transfers do not involve any site changes relating to the location of
106 the private sewage system, and for the revision of a sanitary permit due to a change in
107 plumber.
- 108 (4) There shall be a county fee of ~~\$172~~189.00 for the preliminary on-site inspections of
109 soils by the department as provided for in sections 46.10, 46.14(4)(c), and 46.45. Fees
110 paid under this subsection shall not be used to reduce or offset the fee for the issuance
111 of any permit under this chapter.
- 112 (5) There shall be a county fee of ~~\$181~~199.00 for any private sewage system
113 inspections or re-inspections which are either not included in the sanitary permit fee or
114 are not specifically required by the plumbing code, or both.
- 115 (6) There shall be a county fee of ~~\$545~~9.00 for a verification from the department's files
116 of data relating to water and private sewage systems. This fee shall also be applied for
117 review performed under s. 46.14(3)(a)4.
- 118 (7) There shall be an additional county fee of \$153 for any inspection performed after
119 normal work hours and at the request of any person for whom performed.
- 120 (8) There shall be a county fee of ~~\$142~~123.00 for an on-site verification of a private
121 sewage system when requested in connection with securing financing of the subject
122 property.
- 123 (9) The county fee for the collection of a water sample for bacteriological analysis shall
124 be ~~\$142~~123.00 plus the current analysis fee charged by the Department laboratory.
- 125 (10) The county fee for the collection of a water sample for fluoride and nitrate chemical
126 analysis shall be ~~\$142~~123.00 plus the current analysis fee charged by the Department
127 laboratory.
- 128 (11) The county fee for all services listed in subsections (8) through (10) above, when
129 requested to be performed in one site visit, shall be ~~\$224~~246.00 plus the current analysis
130 fee charged by the Department laboratory.
- 131 (12) Each owner of a private sewage system shall annually be charged a fee of
132 ~~\$8,679.54~~ for administration of the inspection programs required by s. 46.11(5). Such
133 fee is authorized by WIS. STAT. s. 145.20(4) and will be collected in the same manner
134 that municipalities may make property assessments pursuant to WIS. STAT. s. 66.0703.
- 135 (13) There shall be a county fee of \$159 for the application for a Wisconsin Fund grant
136 from the department of commerce.

137 (14)(a) There shall be a county fee of ~~\$420~~132.00 for the revision of an issued sanitary
138 permit that has been reviewed and approved by the department as part of a sanitary
139 permit application. The fee in sub. (3) shall apply when the revision is due to a change
140 of plumber.

141 (b) There shall be a county fee of ~~\$85~~94.00 for the review of revisions to a previously
142 approved plan that is submitted to the county pursuant to Wis. Admin. Code s. SPS
143 383.22(1)(c).

144 (15) The fee for the review of a holding tank plan for a residential structure shall be as
145 follows:

<u>Holding tank capacity:</u>	<u>Fee</u>
147 0-5,000 gallons	\$ 90.00 <u>99.00</u>
148 5,001-10,000 gallons	\$ 150.00 <u>165.00</u>
149 more than 10,000 gallons	\$ 225.00 <u>248.00</u>

150 (b) The fee for the review of a holding tank for a commercial structure shall be as set
151 forth in sub. 16(a).

152 (16)(a) The fee for review and processing of a plan that is submitted to the county
153 pursuant to Wis. Admin. Code sec. SPS 383.22(1)(c), shall be as follows:

<u>Design wastewater flow</u>	<u>Fee</u>
155 1,000 gpd or less	\$ 250.00 <u>275.00</u>
156 1,001-2,000 gpd	\$ 325.00 <u>358.00</u>
157 2,001-5,000 gpd	\$ 400.00 <u>440.00</u>

158 (b) There shall be a fee of ~~\$80~~88.00 per hour for review and processing of a plan to
159 replace a septic tank, add effluent filters or other pretreatment devices, or otherwise alter
160 an existing system that was approved under Wis. Admin. Code s. SPS 383.22(1)(c).

161 (17) The fee for the review and processing of an application for an annual septage
162 landspreading permit shall be \$65.

165 ARTICLE 7. Section 47.22 is amended to read as follows:

166 **47.22 ANNUAL DOG LICENSE TAX.** In addition to the statutory tax, there is hereby
167 added an additional tax of ~~\$6.00~~11.00 for each dog license applied for. The purpose of
168 the additional tax is to pay for the cost of housing and care of stray, abandoned or
169 impounded animals pursuant to Wis. Stat. s. 173.15(1).
