- 1. Additional TB purchases \$2000 remaining in budget. The Board discussed building more tree cribs for Sun Prairie Elementary and Thoreau (no vote on this item yet)
- 2. Internal Dane County Tree Preservation Resolution BRODBECK wants to see samples of resolutions so she understands framework and what needs to be in it. RITT says if a bulleted list of what the board wants in it is provided, she can work with County Board staff and Corporate Counsel to help write it and turn it into a resolution. The department involved in the resolution also needs to approve. The list will be generated at the next meeting on July 16.
- 3. DCTB Application to the Bock Foundation Grant was submitted for funding to create a model tree preservation ordinance; CARPC would work on it with DCTB if funded. NOONE would recuse as he is a CARPC employee; others on staff would work with the Tree Board
- 4. Tree Board applicants. Two applicants applied for the 9th seat on the Board. Candidates are Kate Kendziora and Sean Gere. After much discussion, a motion was made for the DCTB chair to write an email letter to the County Exec's office to recommend Kendziora for the seat.
