Brief Description of Proposal -

LWRD and NHLT recommend the exchange of properties at Patrick Marsh and the North Mendota land and water legacy site. The County would become the owner of the NHLT property at the North Mendota land & water legacy site and NHLT would become the owner of County property at Patrick March. The purpose of the exchange is to increase efficiencies, reduce operating costs and create a seamless public experience.

Current Policy or Practice -

Land exchanges of county property require County Board approval.

Impact of Adopting Proposal -

The properties impacted by the exchange would be deed restricted so that they could only be used for natural resource protection and recreation. Additionally, the County would receive funds from NHLT to be used for the care and maintenance of the property deeded to the County.
