Masking Policies

SSM Health has had no change to masking policies in the last month. Meriter is not requiring masks in congregate areas, still required with patients. UW - Same. Stoughton Hospital has no mandate. Discussed consistency with EMS agencies, common sense approach if possible with masking. It is a personal choice and respect rules of facilities and patients. CDC community levels are less reliable, use community level risk as a guide? DeerGrove will not change policy of surgical masks with all patients. Question about return to work policies when exposed to Covid, how do we return to general respiratory infections?

CARES data: In Dane County, 14% of cardiac arrest victims survived. State = 10%, Nation = 9%. Survival with bystander intervention 53.7%. State = 36%, Nation = 30.6%. 65% of cardiac arrests had bystander cpr initiated, and nationally it was only 34.2%
