**AUTHORIZING AN AGREEMENT TO ACCEPT GRANT FUNDING FOR THE PURCHASE
OF RESPIRATORS AND COMMUNICATION EQUIPMENT**

The Homeland Security (HS) – Wisconsin Emergency Management (WEM), Wisconsin Department of Military Affairs Grant Program is providing \$8,000 funding to the Sheriff's Office to purchase air purifying respirators with radio communication connection equipment; Grant Number 2022-HSW-02A-13211, funding is available December 30, 2022 through October 27, 2023.

This grant supports the Aligned Law Enforcement Response Team initiative by providing funding to purchase respirator and communication equipment for the Sheriff's Office Tactical Response Team (TRT). Air purifying respirators with enhanced digital radio communication connections and integrated digital voice protection devices are required to facilitate the sharing of information during high risk critical incidents and to protect against exposure to toxic atmospheres, harmful levels of particulates, chemicals, biological agents, and other contaminants.

NOW, THEREFORE, BE IT RESOLVED that the Sheriff's Office is authorized to accept \$8,000 from HS WEM to purchase respirators with radio communication connection equipment, and on behalf of the County of Dane, the County Executive is authorized to execute an agreement embodying the above provisions; and

BE IT FURTHER RESOLVED that \$8,000 is appropriated as additional revenue in the Sheriff's Office, Field Services Division, TRT Grant Revenue (SHRFFLD 80728) and is credited to the General Fund; and

BE IT FINALLY RESOLVED that \$8,000 is transferred from the General Fund to Sheriff's Office, Field Services Division, TRT Equipment and Uniforms (SHRFFLD 48848).

3. Equipment shall be maintained and available to use as intended by the grant for the duration of its useful life. The sub-recipient is required to maintain proper equipment records. Sub-recipient seeking to dispose or transfer ownership of equipment must contact Wisconsin Emergency Management (WEM) Homeland Security Staff to obtain the Homeland Security Equipment Disposition Form, and further directions. Agreement Articles for Federal Fiscal Year 2022 Homeland Security Awards

Article I - Summary Description of Award

The purpose of the FY 2021 HSGP is to support state and local efforts to prevent terrorism and other catastrophic events and to prepare the Nation for the threats and hazards that pose the greatest risk to the security of the United States. The HSGP provides funding to implement investments that build, sustain, and deliver the 32 core capabilities essential to achieving the National Preparedness Goal of a secure and resilient Nation. Among the five basic homeland security missions noted in the DHS Quadrennial Homeland Security Review, HSGP supports the goal to Strengthen National Preparedness and Resilience. The building, sustainment, and delivery of these core capabilities are not exclusive to any single level of government, organization, or community, but rather, require the combined effort of the whole community. This HSGP award consists of State Homeland Security Program (SHSP) funding in the amount of \$4,602,500. This grant program funds a range of activities, including planning, organization, equipment purchase, training, exercises, and management and administration across all core capabilities and mission areas.

Article II - Limited English Proficiency (Civil Rights Act of 1964, Title VI)
