AUTHORIZING EXTENSION OF TIME FOR LIMITED TERM EMPLOYEE IN THE SHERIFF'S OFFICE

Policy Analysis Statement:

Brief Description of Proposal -

The Sheriff's Office employs limited term employees (LTE) in the Weapon Screening Unit at the Dane County Courthouse for security screening coverage that is essential in maintaining the safety of staff and the public who use the Courthouse. The Sheriff's Office is requesting the County Board grant an exception to Dane County Ordinance 18.16 to permit one LTE to exceed 1,200 hours by up to 120 hours, for payroll year 2024.

Current Policy or Practice -

Exceptions to Dane County Ordinance 18.16 requires County board approval.

Impact of Adopting Proposal -

Adopting this resolution will permit an LTE employed by the Sheriff's Office, Weapon Screener Unit, to exceed 1,200 hours in payroll year 2024, for up to an additional 120 hours. The additional 120 hours of LTE time provides the necessary staffing coverage required for the effective operation of the Weapon Screening Unit until staff vacancies are filled.
