# **Policy Analysis Statement:**

#### Brief Description of Proposal -

Request authorization to accept grant funds from the FY 2016 Edward Byrne Memorial Justice Assistance Grant Program, in the amount of \$23,580 to be used as follows: \$6,330 to the Sheriff's Office to purchase gas masks/filters, helmet lights, and an infrared illuminator scope; \$11,500 for the Dane County Drug Court Treatment Program; and \$5,750 for the Dane County District Attorney Crime Response Program. Funding of \$11,500 for the Drug Court Treatment Program and \$5,750 for the District Attorney's Crime Response Program are ref lected in the 2016 Adopted Budget. The City of Madison will administer the grant funds.

# Current Policy or Practice -

Acceptance of grant funds requires County Board approval.

### Impact of Adopting Proposal -

The purchase of gas masks/filters, helmet lights, and an infrared illuminator scope will assist with criminal investigations and provide safety equipment to Deputies.
