## 2017-19 CONTRACT WITH THE GREATER MADISON CONVENTION & VISITOR'S BUREAU

## **Policy Analysis Statement:**

Brief Description of Proposal -

This proposal is for a three-year agreement with the Greater Madison Convention & Visitors Bureau for general marketing and other services, sports development incentives, and support of the Madison Areas Sports Commission. The agreement follows the 2017 budgeted amounts of \$239,951 for general marketing and other services, \$39,600 for sports development incentives, and \$14,650 in support of the sports commission.

Current Policy or Practice -

The GMCVB submits requests for payment to the Dane County Controller. This multi-year contract requires County Board and County Executive approval.

Impact of Adopting Proposal -

Adoption of this proposal authorizes a three-year agreement with the Greater Madison Convention & Visitors Bureau for general marketing and other services, sports development incentives, and support of the Madison Areas Sports Commission.
