This project will replace all of the existing parking lot, walkway, and access road lighting fixtures (not including the poles) at the Alliant Energy Center with high efficiency LED lighting. The Committee reviewed three additional fixture design options; the VXM/VXS Vision Site, the Gleon Galleon, and the TLM/TLS Talon. The Gleon Galleon was selected as the best option in terms of aesthetics and cost-effectiveness. An estimated cost of up to \$460,000 was approved including a 5% contingency. In response to a concern about light pollution, FRANZ stated that the fixtures meet the guidelines of the International Dark-Sky Association. CLARK noted that new poles could be phased-in as needed in the future.

A motion was made by MYREN, seconded by ERICKSON, that the Action Item be approved. The motion carried by a voice vote.
