AUTHORIZING SUPPLEMENTAL LEASE WITH USDA FARM SERVICE AGENCY AT LYMAN ANDERSON AGRICULTURE & CONSERVATION CENTER

Brief Description of Proposal -

The Dane County Committee of the Farm Service Agency (COC) lease expired on September 30, 2008. COC has continued to lease 2,687 square feet for the USDA-FSA local offices at the Lyman F. Anderson Agriculture and Conservation Center under a supplemental lease agreement at a rental rate of \$15.00 per square foot since 2008. Another supplemental lease has been submitted to extend the existing lease.

Current Policy or Practice -

Impact of Adopting Proposal -

The existing rental rate is \$15.00 per square foot or \$40,305 annually through September 30, 2018 or until Dane County completes its planned remodeling for all USDA offices at the Lyman F. Anderson Agriculture and Conservation Center. A new lease for the remodeled and additional space will be negotiated at that time. The county and the agricultural constituencies benefit from having these agencies collocated.
