**AUTHORIZING A CONTRACT FOR ADDITIONAL POLICE SERVICE WITH THE
TOWN OF COTTAGE GROVE**

The Town of Cottage Grove has requested the Dane County Sheriff's Office provide additional police service within the boundaries of said township, at a level above and beyond the basic level of police service beginning 1/1/2015. The Town of Cottage Grove has agreed to compensate Dane County for the cost of providing three full-time Deputy Sheriffs (three FTE) and one squad car, to provide requested additional police service, effective 1/1/2015.

NOW, THEREFORE, BE IT RESOLVED that the Dane County Sheriff, Dane County Executive, and Dane County Clerk are authorized to enter into a policing contract with the Town of Cottage Grove, effective 1/1/2015, and

BE IT FURTHER RESOLVED that a new revenue account line is created in Sheriff, Field Services, Town of Cottage Grove (SHRFFLD-NEW), the amount of revenue to be received in 2015 from this contract will be included in the 2015 budget, and

BE IT FURTHER RESOLVED that the Dane County Sheriff's Office is authorized to hire three Deputy Sheriff positions in the 2014 Budget for the Town of Cottage Grove Policing Contract, effective 9/8/2014, at a cost of \$74,900, from 9/8/2014 – 12/31/2014, to allow for training before Deputy Sheriffs can fulfill duties independently and to avoid incurring overtime costs at the effective date of the contract, and

BE IT FINALLY RESOLVED that \$74,900 is transferred from the General Fund to the following Sheriff's Office accounts:
