Staff is direct to pursue a condition requiring a surety bond for assurances of spill clean up due to the increase pressure that the pumping station will create on the existing line. Staff will work with Risk Management and Corporation Counsel to determine the language of the surety bond. The bond shall list Dane County as a insurer, determine the risk associated with a spill, ensure the restoration of lands, and required an environmental study be conducted after clean-up. The motion carried by a voice vote. YGM: 2-0.

1. The Committee would like more information regarding the 2006 WDNR Environmental Assessment Report regarding Enbridge Line 61. The Committee would like to know if the report accounted for the proposed increase in pressure of pipeline and the transportation of tar sands.
2. The Committee also requested that Enbridge produce documentation regarding proof of insurance for a catastrophic event.
3. The Committee would like the WDNR to review the scope of the pipeline assessment to see if an Environmental Impact Statement is needed.
