

AMENDED

INTERGOVERNMENTAL AGREEMENT RELATING TO THE SHARING OF COSTS FOR IMPROVEMENTS TO CTH M (SOUTH JUNCTION ROAD) & CTH S (MINERAL POINT ROAD) AND FOR THE JURISDICTIONAL TRANSFER OF A PORTION OF CTH S TO THE CITY OF MADISON

1. Dane County and the City of Madison previously entered into an agreement captioned "Intergovernmental Agreement Relating to the Sharing of Costs for Improvements to CTH M (South Junction Road) & CTH S (Mineral Point Road) and for the Jurisdictional Transfer of a portion of CTH S to the City of Madison" ("Original Agreement") which was fully executed on March 10, 2015.
2. This amendment to the Original Agreement increases Dane County's final share of the total costs of the Project from \$2,860,700 to \$2,900,700.
3. All other terms of the Original Agreement, not changed by this Agreement, shall remain in full force and effect.
