Intent/Justification The Land and Water Volunteer Coordinator position is essential to the department's operations and community engagement. It oversees a network of 2,500–3,000 volunteers who collectively contribute tens of thousands of hours each year to maintain and enhance the county's parks and natural areas. Without this position, the county risks losing critical volunteer support that sustains many of its environmental and public service initiatives. As a long-standing and proven role, the Volunteer Coordinator ensures continuity, organization, and effectiveness within the volunteer program—making it a vital position for maintaining the department's current level of operations and service. This amendment includes a \$25,836 LTE expense reduction to partially offset the restoration of the Volunteer Coordinator. The amendment is proposed as PWT-O-01 provides additional savings of \$149,300 by eliminating the Operations Supervisor at the Alliant Energy Center. The balance of funds from PWT-0-01 will be used to partially fund the Immigration Affairs Specialist position.
