Step 1: Enter Total Number of Convictions in Cell F5 (confirm match in Cell R36 when complete)

Step 2: Enter Total Fine Amount for any counts in Cells H15, J15, M15 or O15

Step 3: Change H23 and/or M23 from "No" to "Yes" if Drug Related Offense

Step 4: Enter Total Number of Convictions without Domestic Abuse Surcharge in Cells H30, J30, M30 or O30

Step 5: Enter Total Number of Convictions with Domestic Abuse Surcharge in Cells H34, J34, M34 or O34
