AUTHORIZING AN AGREEMENT TO ACCEPT GRANT FUNDING FOR THE PURCHASE OF NIGHT VISION EQUIPMENT

Policy Analysis Statement:

Brief Description of Proposal -

Request approval to accept grant funds to purchase night vision equipment for use by the Tactical Response Team (TRT) in a variety of special situations that are beyond ordinary law enforcement capabilities. Applications for night vision equipment include surveillance, searches for individuals in low light conditions, search and rescue efforts, and evidence recovery.

Current Policy or Practice -

Acceptance of grants requires approval of the County Board.

Impact of Adopting Proposal -

The Dane County Sheriff's Office TRT requires specialized equipment to enhance the ability of the Team to safely intervene in high-risk events like hostage situations and to safely resolve these situations. TRT duties include hostage rescue, VIP protection details, resolving high risk situations, and providing assistance on arrest and search warrants.
