ACCEPTING STATE OF WISCONSIN -"BRIGHTER FUTURES INITIATIVE" GRANT MONIES DEPARTMENT OF HUMAN SERVICES (DHS) - DIVISION OF CHILDREN, YOUTH, AND FAMILIES (CYF)

Policy Analysis Statement:

Brief Description of Proposal The Department of Human Services accepts State of Wisconsin – Brighter Futures Initiative grant monies in the amount of \$208,333 for the period March 1, 2015 - December 31, 2015. Dane County receives these monies following a successful RFP submission. Monies will be allocated to four entities. Three agencies will provide direct services to youths at risk of involvement in the juvenile justice system: YWCA (restorative justice circles), Dane County Timebank (youth peer court services), and Briarpatch – Youth Job Center (employment services). A fourth agency (entity TBD) will provide required program evaluation services.

Current Policy or Practice -

Budget and professional service contract changes require County Board approval.

Impact of Adopting Proposal -

Three agencies will provide direct services to youths at risk of involvement in the juvenile justice system: YWCA (restorative justice circles), Dane County Timebank (youth peer court services), and Briarpatch - Youth Job Center (employment services). A fourth agency (entity TBD) will provide required program evaluation services. If the funds are not accepted Dane County will not provide the additional services supported by these monies.
