1. Legislative Update from Mickey Beil, Dane County Legislative Lobbyist

Mickey Beil, Legislative Lobbyist addressed the committee. She reviewed the County Executive memo summarizing the state budget. She spoke of ADRC changes, Family care, MMSD appointments, among other things.

Discussion ensued regarding Enbridge. There was a request for more information on stewardship and crime prevention board.

Beil also outlined additional issues: Bucks Arena, Heroin package (non-violent 17yr olds will be taken out of adult prison and returned to the juvenile correctional center or the community), legal council study committee on open records, frac sand mining and local control and potentially getting rid of the Family Medical Leave Act (FMLA).
